**Insect Repellant**

The JCC Early Childhood Center (ECC) will apply Insect Repellant to children under the following conditions:

- The Washtenaw County Health Department has recommended use of repellants to prevent disease transmission.
- Parents have signed a form (see below) giving the ECC permission to apply insect repellant.
- Parents have provided the ECC with an insect repellant that is labeled with their child's name, and which contains DEET (20% or less) , Picaridin/KBR 3023, Oil of Lemon Eucalyptus/PMD **or** IR3535 (DEET is not permitted for children under 2 months, and Oil of Eucalyptus is not permitted for children under 3 years.)

Per our consulting pediatrician, information provided by both the Washtenaw County Health Department and the American Academy of Pediatrics, the ECC will apply repellant using the following guidelines:

- Repellant containing DEET will not be used on children under the age of 2 months.
- Hands will be avoided, so that repellant does not get rubbed in children's eyes.
- Parents who wish to have their child use a repellant which does not meet our guidelines must fill out a medication permission form.
